

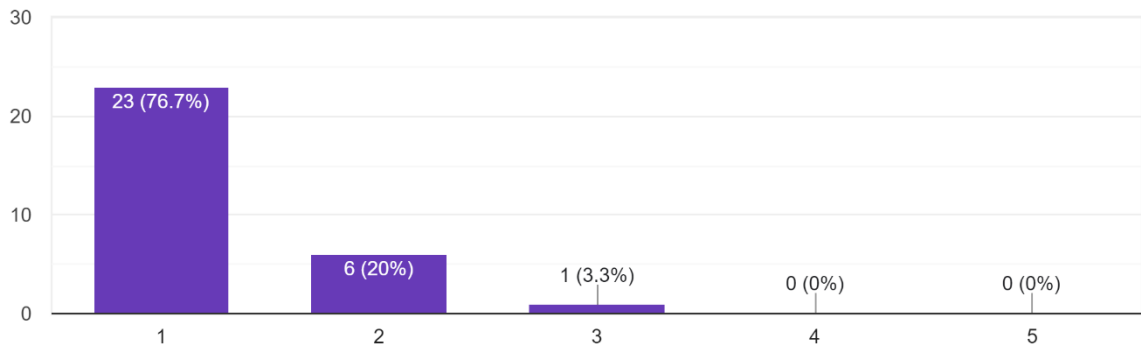

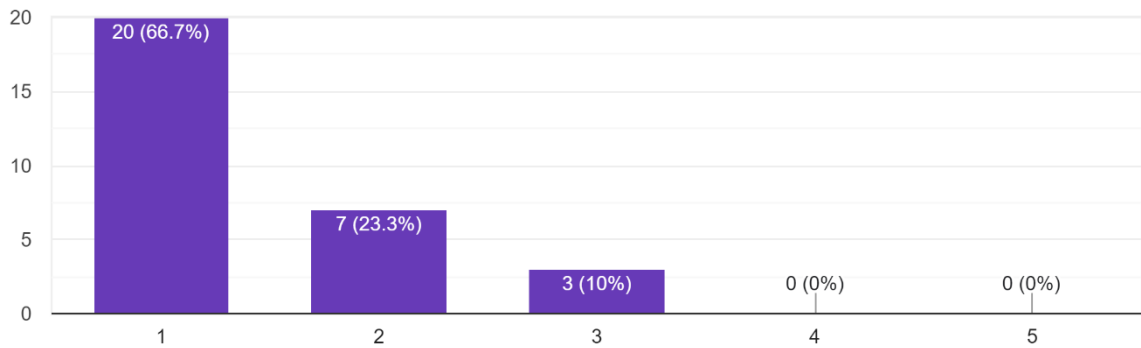
1. Do you feel that you have freedom of thought and expression in your research ?

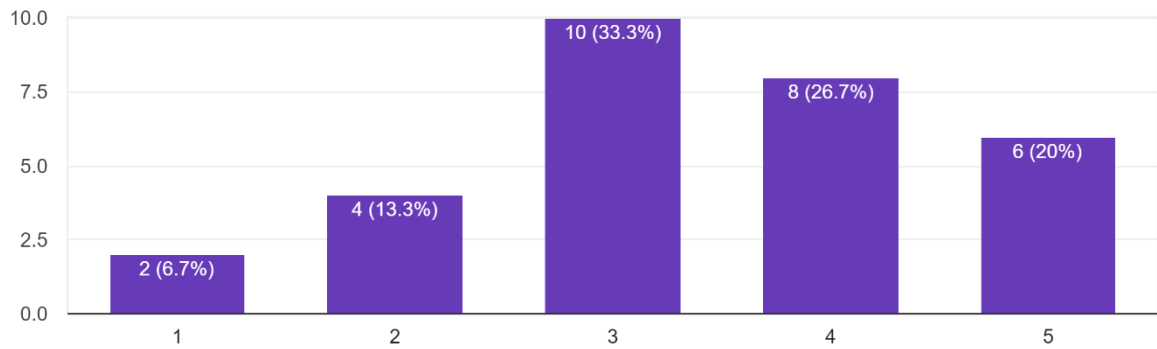
2. Do you feel free to determine your own methods of research ?

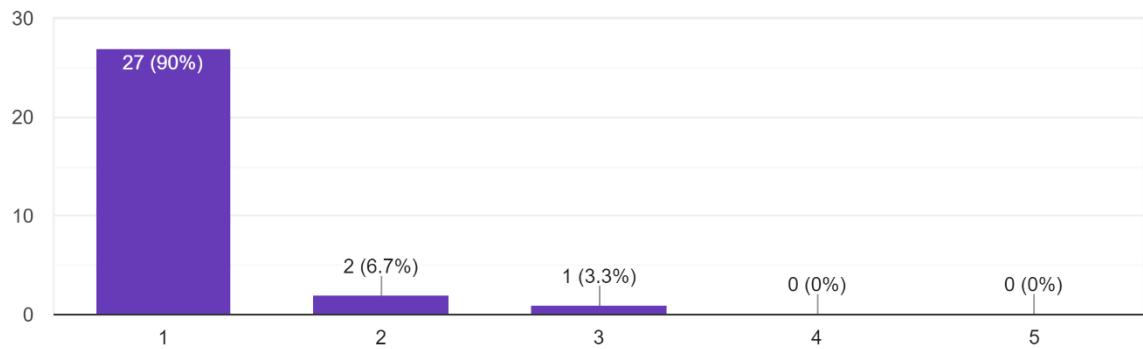

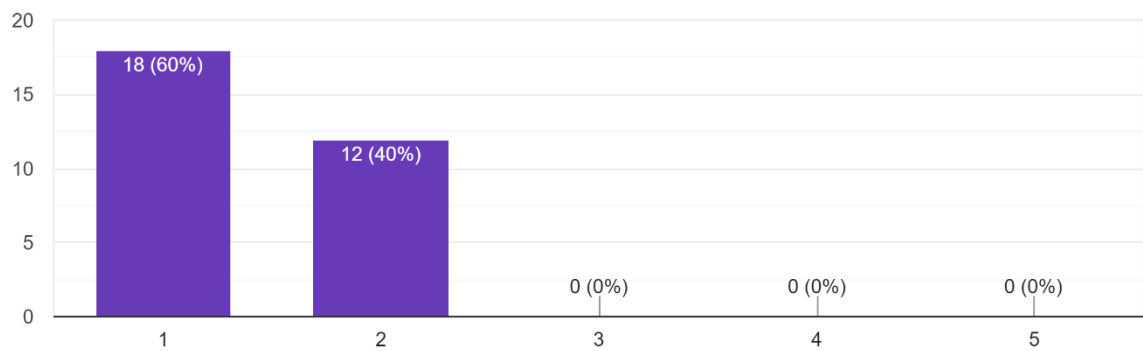
4. Do you think that adherence to ethical principles is important in research ?

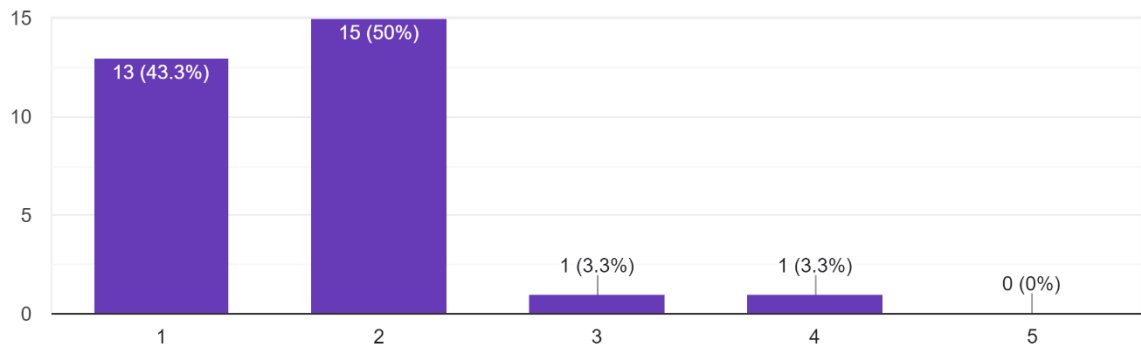

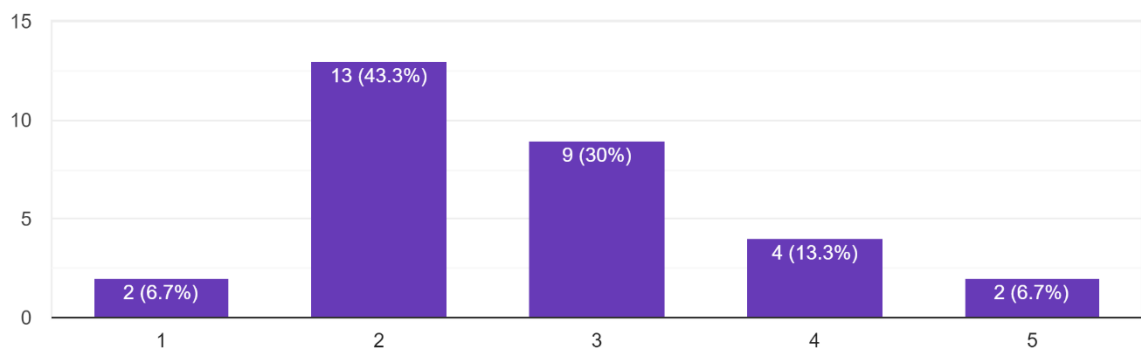

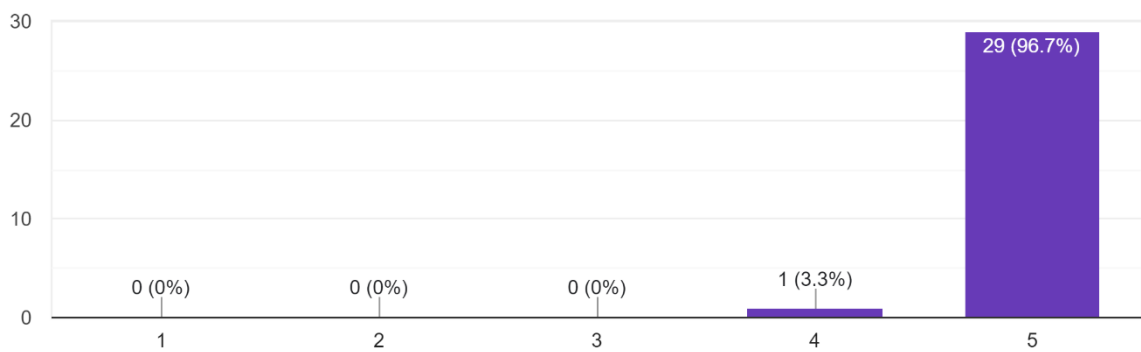

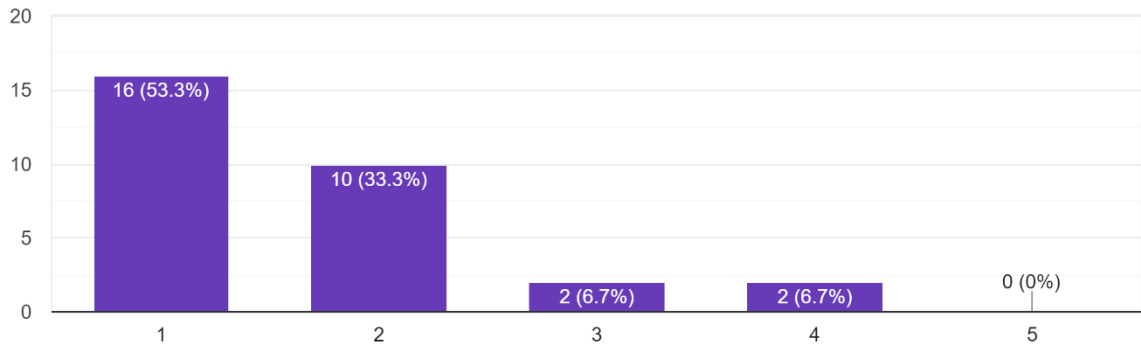

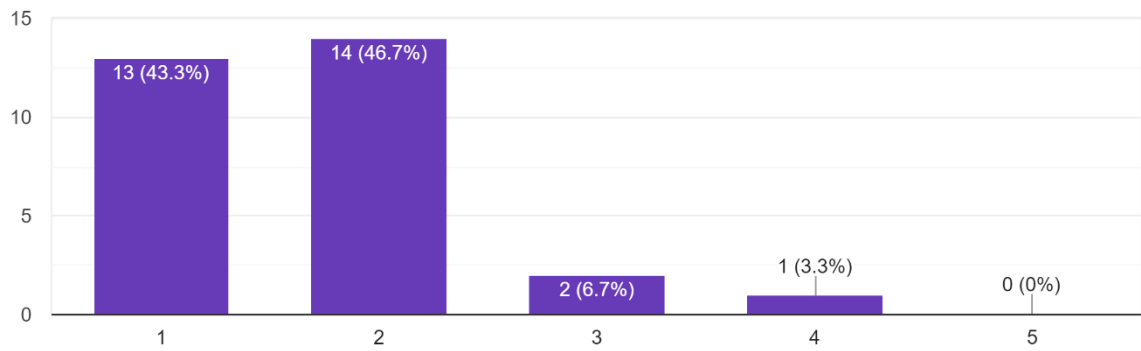

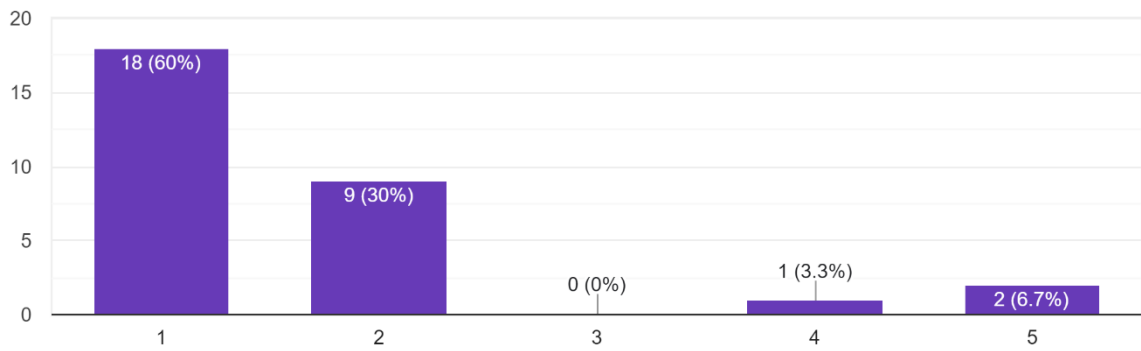

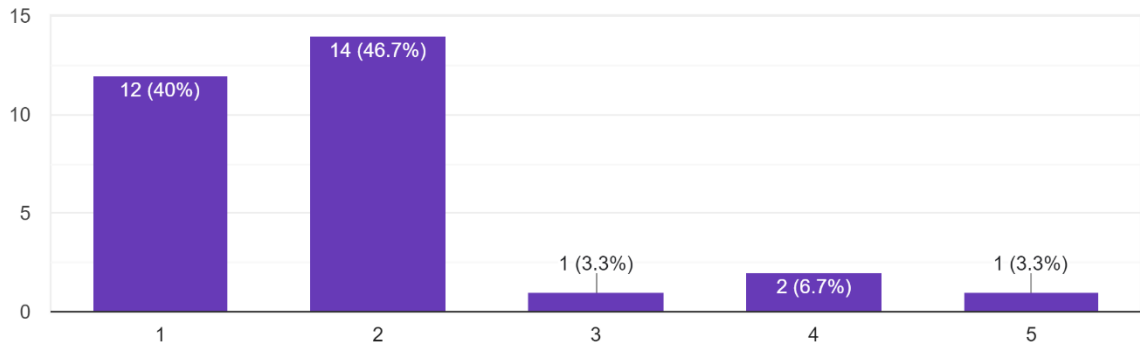

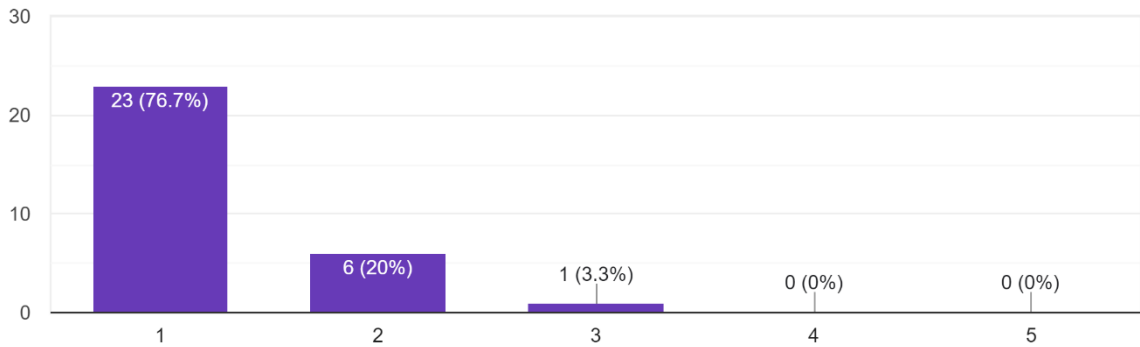

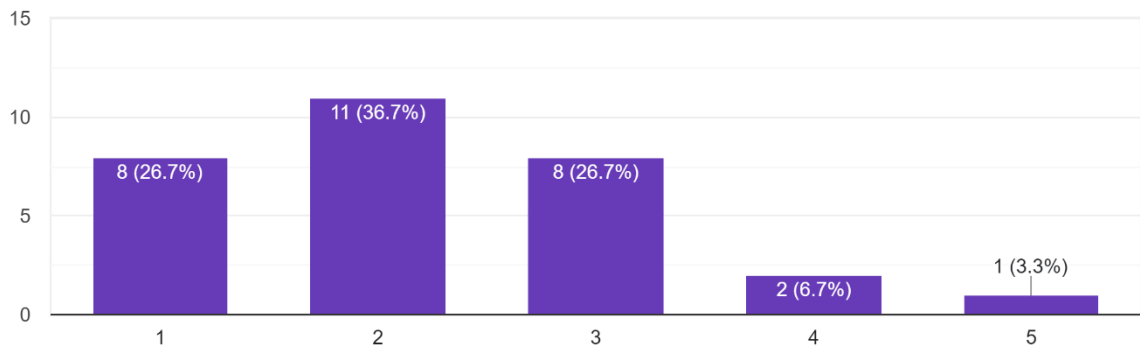

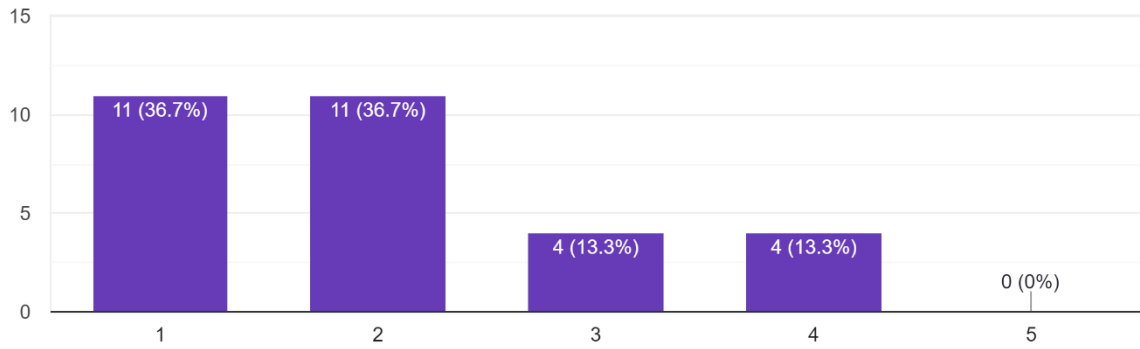

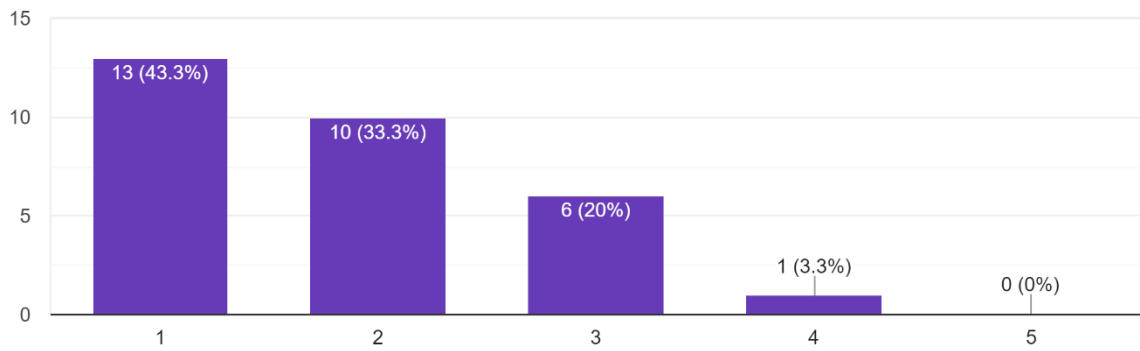

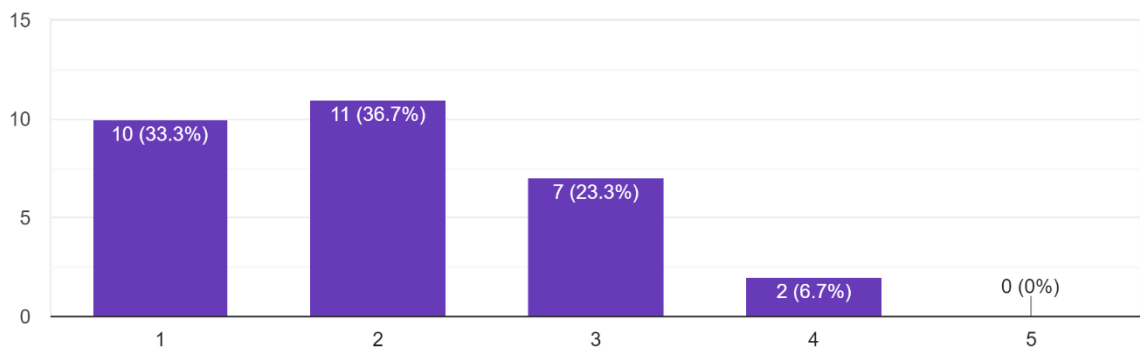

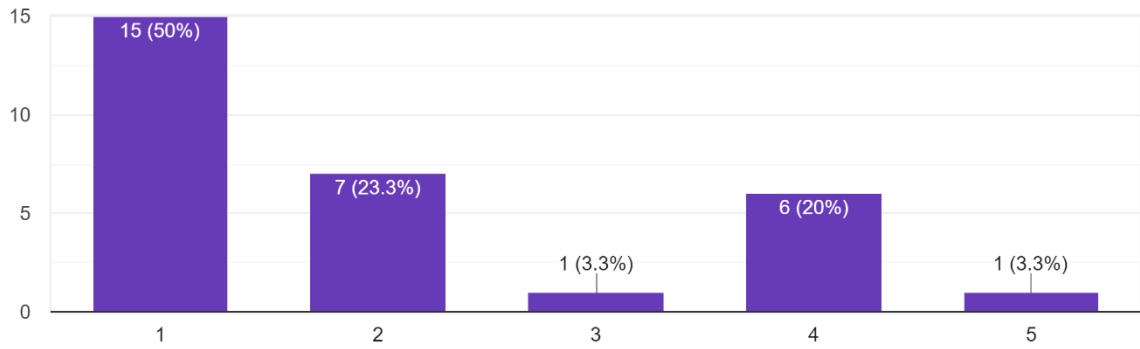

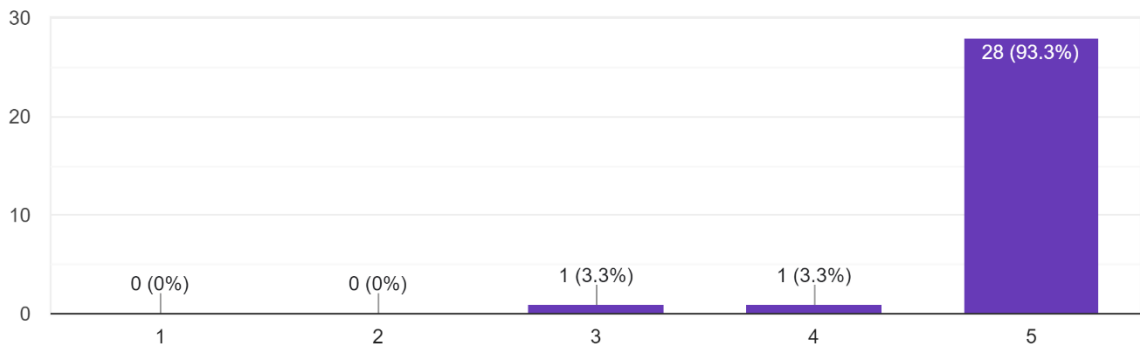

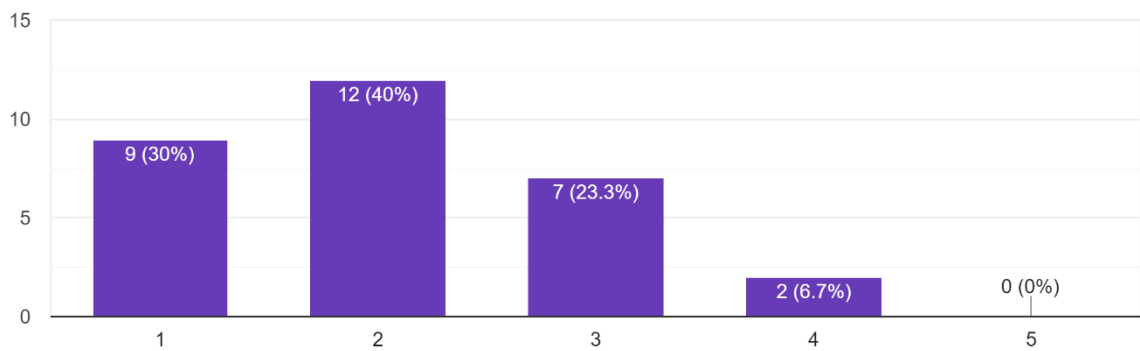

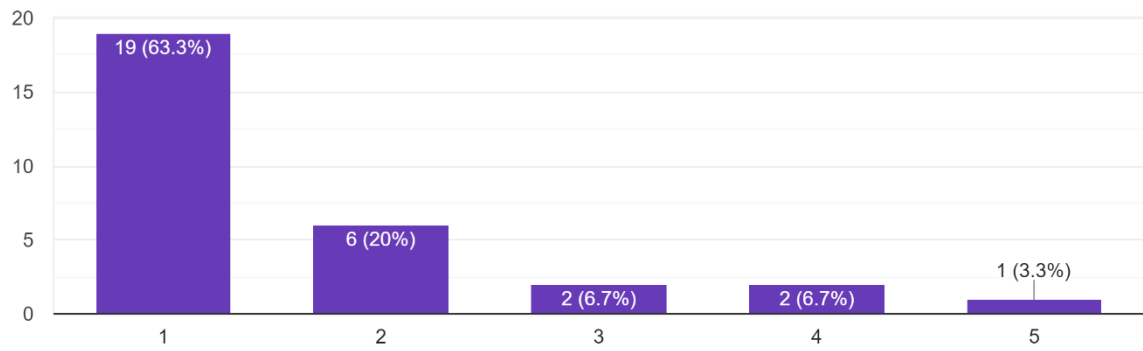

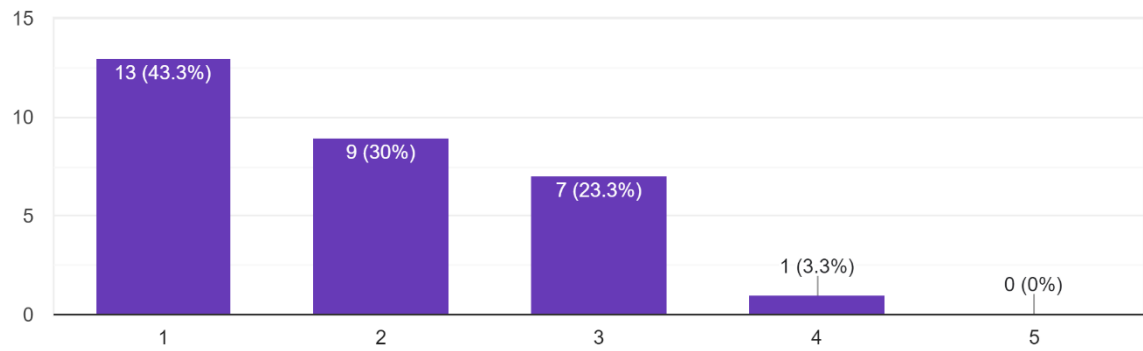

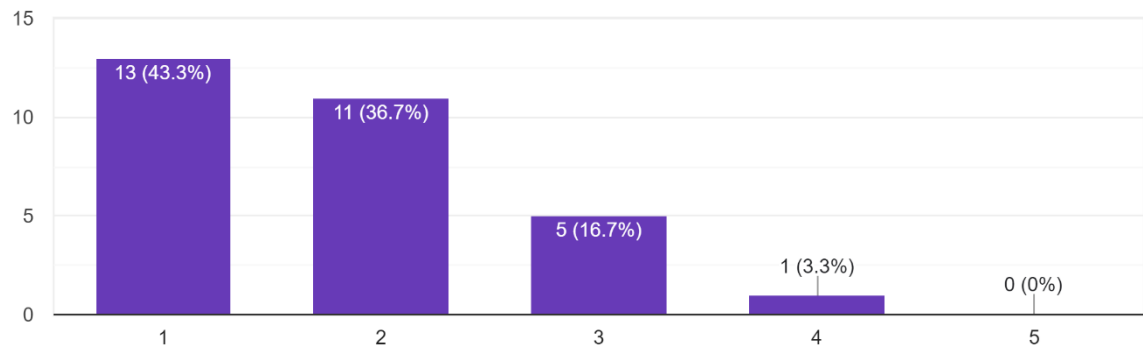

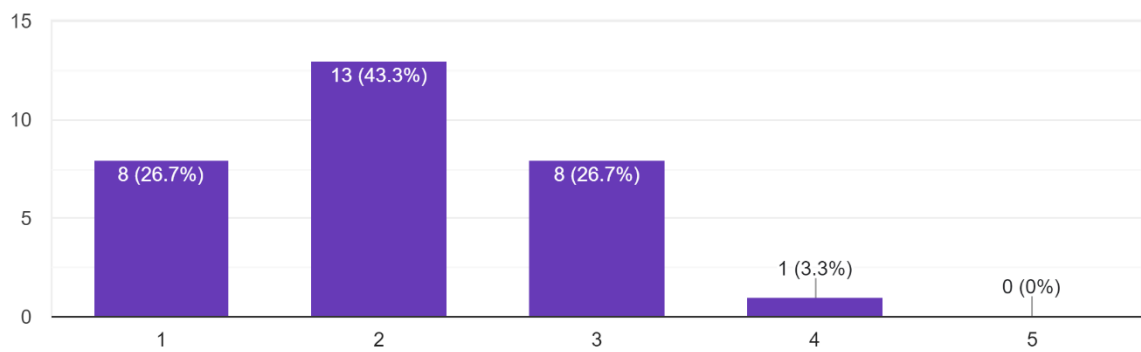

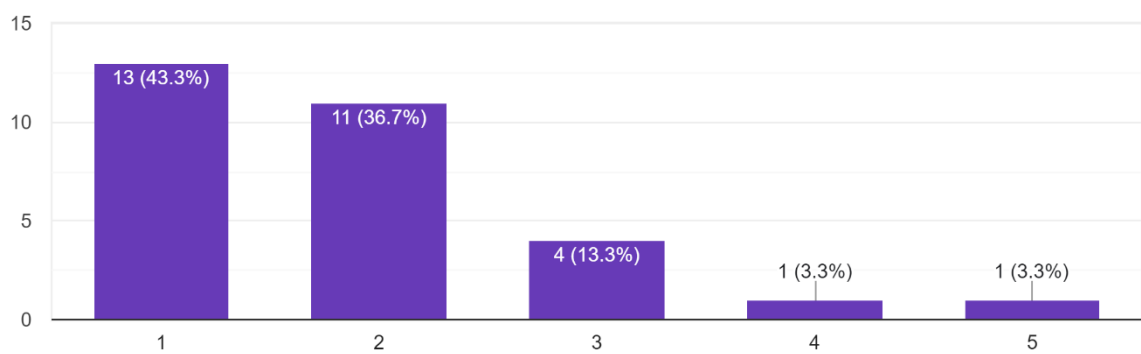

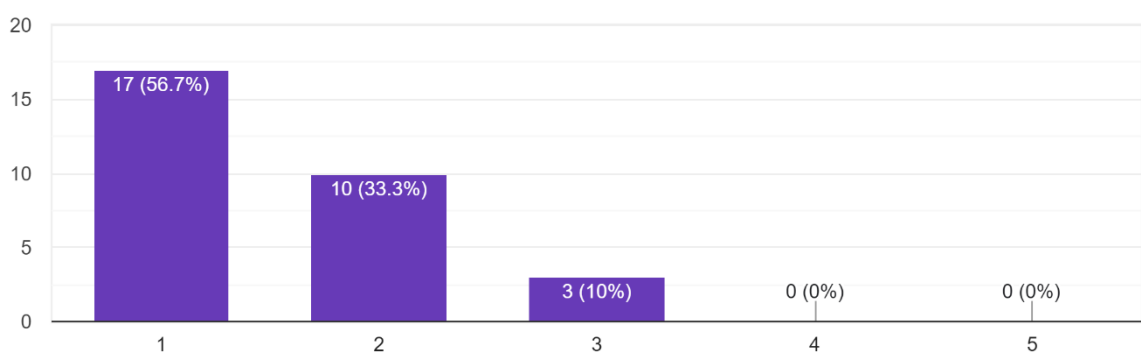

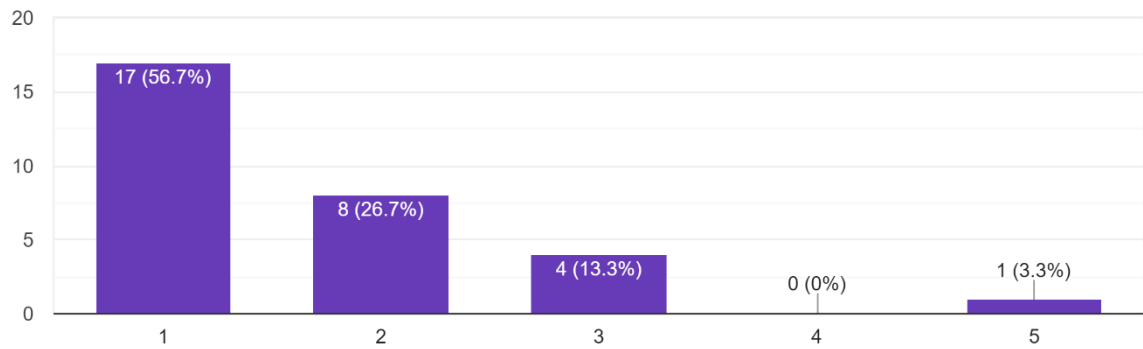

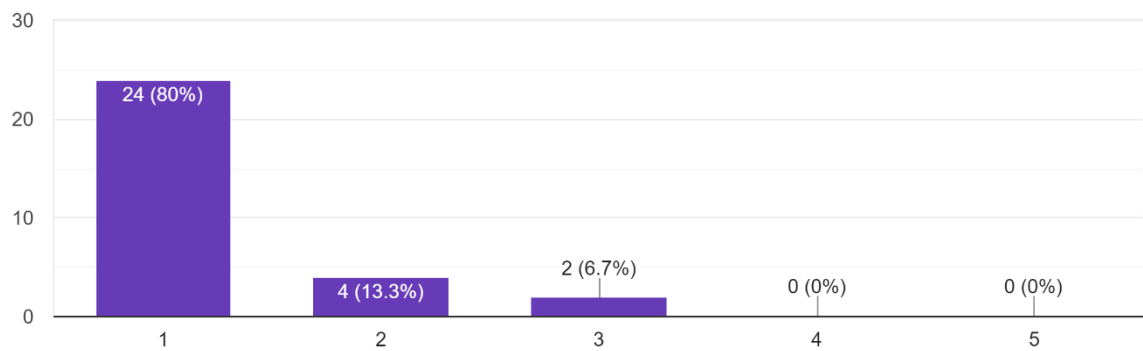

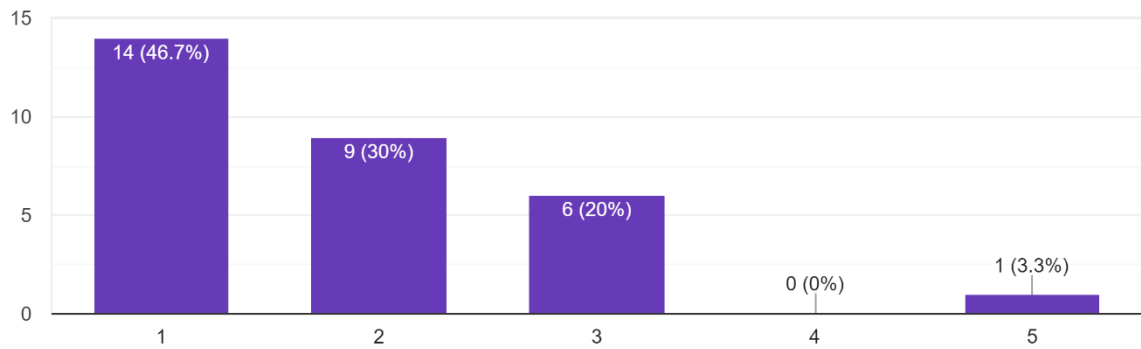

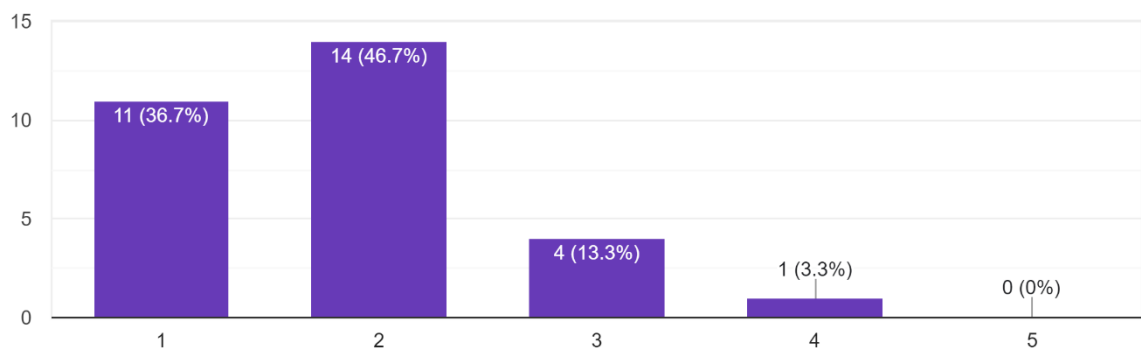

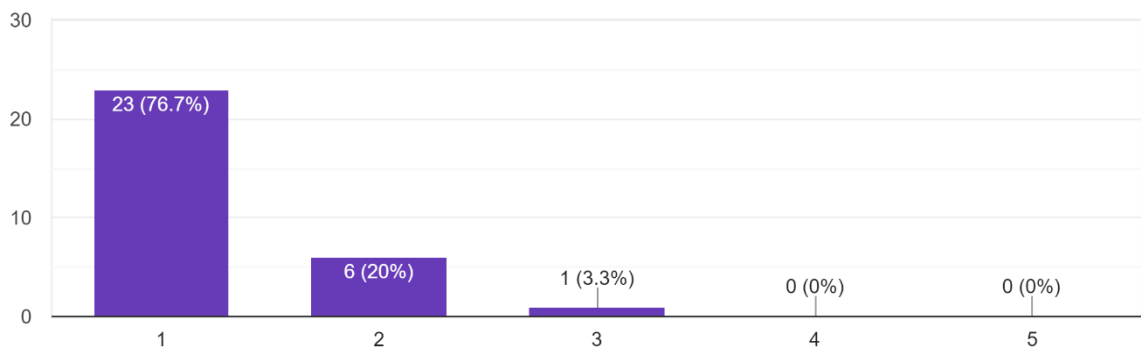

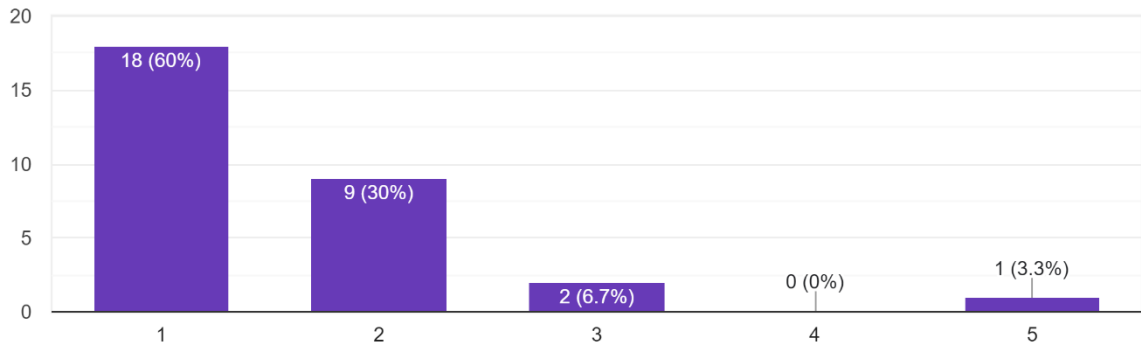

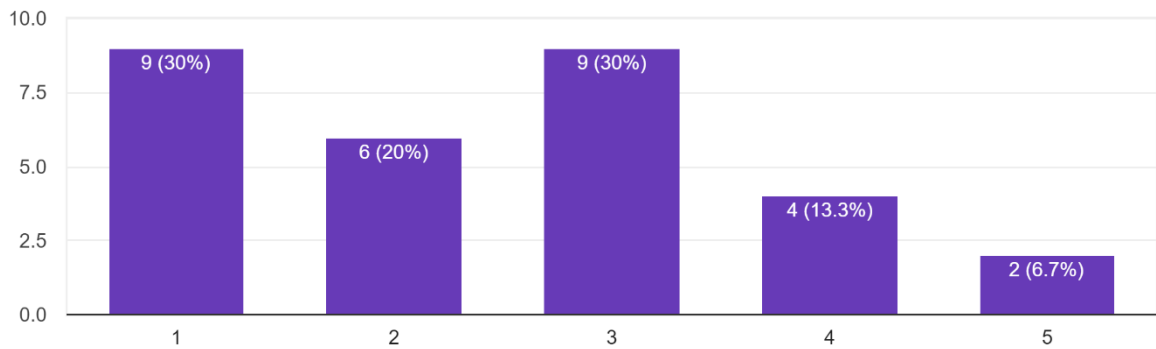

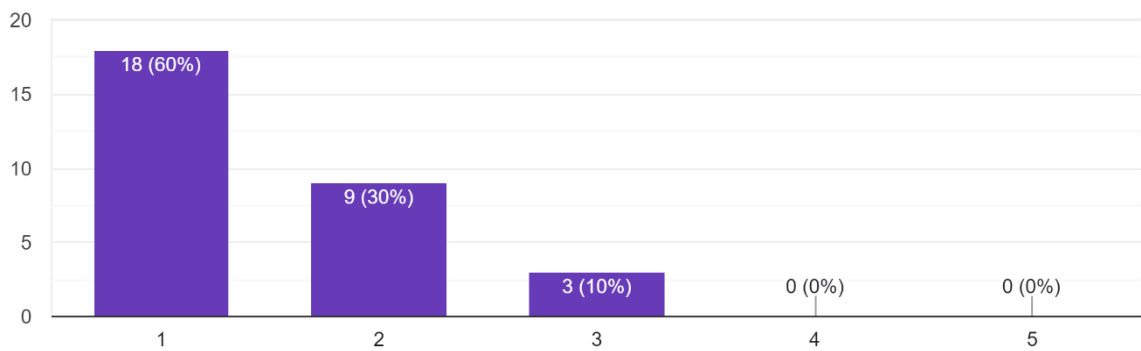
